Description Regents Item:	The Neighborhood Charter School of Harlem is authorized to serve a maximum of 323 students in grades K-5. They currently serve students in grades K-4 between two buildings in NYC CSD 5 & 6. The school requests the maximum permitted enrollment be increased from 323 to 375 students for the 2016-17 school year.

The application for this school is being reviewed for possible action at an upcoming Board of Regents meeting.

Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <http://www.p12.nysed.gov/p12/law.html>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing revision. This hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.
