Background and Instructions**Background**

Section 9-a of part A of chapter 56 of the laws of 2021, as amended by §5-a of part A of chapter 56 of the laws of 2022 requires, on or before July 1, 2022, every local educational agency (LEA) receiving funding from the Elementary and Secondary School Emergency Relief (ESSER) funding from the American Rescue Plan (ARP) act of 2021 to post on its website and submit to the New York State Education Department (NYSED) an updated plan of how such funds will be expended and how the LEA will prioritize spending on non-recurring expenses as defined in section 9-a(1) of part A of chapter 56 of the laws of 2021. This updated plan must include:

An analysis of public comment;

Goals and ratios for pupil support;

Detailed summaries of Investments in current year activities; and

Balance of funds spent in priority areas.

In addition, Section 10-d of part A of chapter 56 of the laws of 2021, as amended by §5-b of part A of chapter 56 of the laws of 2022, requires school districts receiving a foundation aid increase of more than 10% or \$10,000,000 must create plans on how these funds will be used to address student performance and need.

The district shared the draft plan at a BOE meeting and then posted it to the district website. We then launched a Thoughtexchange to solicit feedback. Feedback was supportive of the addition of 4 intervention teachers at the elementary schools as well as building substitutes for each school as all recognized that there would be additional learning needs for intervention and due to COVID quarantine rules, staffing was problematic and caused school closures in the prior year. Any assistance with substitute teaching would help to keep the schools open. Additionally, using funds for a COVID coordinator was supported to facilitate health and communication.
